#### DISCUSSING YOUR PLANS

Leaving a gift in your will is a very tax efficient way of donating as it is free from inheritance tax, and gifts of shares and property are exempt from capital gains tax.

If you are considering leaving a gift to the School in your will, our RBAI Foundation Director will be pleased to talk to you in confidence about your wishes and intentions. We are unable to offer legal or financial advice, but we are happy to answer your questions about legacies in general.

A will is very personal, and we fully understand if you prefer to keep your intentions private. However, if you do wish to let us know about a legacy to the School, we will be able to thank you personally and keep you informed about the impact your gift could make.

#### MAKING OR CHANGING A WILL

We strongly advise that you seek professional advice when drafting your will. The easiest way to update an existing will is through a codicil document.

#### HOW TO WORD YOUR GIFT

You may find the following wording helpful when you and your solicitor are considering your gift to RBAI:

#### **Residuary Legacy:**

Part or the balance of your estate, after taxes, charges and other legacies have been settled.

#### **Pecuniary Legacy:**

An exact sum of money for a named beneficiary. You may wish to discuss with your adviser how to index link/ protect the real value of your gift from inflation over time.

#### **Specific Gift:**
